# Maj. Gessford, Retired Head Of Police, Dies

## **Noted for His Service in Unknown Soldier Demonstration**

Maj. Harry L. Gessford, former superintendent of police, died yesterday at his home, 4713 Piney Branch road, from an illness which began previous to his retirement from the superintendency in 1921.

The major illness was attributed to overwork in making police arrangements for the huge demonstration held here during the burial of the Unknown Soldier. In the two weeks preceding the ceremony he made more than 2,000 police details, a record for the department.

Maj. Gessford joined the department in January, 1881, at the time his father, James W. Gessford, was a lieutenant on the force. He became a first class private in 1892 and acting sergent in 1899. In 1901 he was made a sergeant, the next day a lieutenant and the day following, a captain. Five years later he was promoted to the post of inspector, and on August 10, 1919, he was appointed assistant superintendent of police, under Maj. R.W. Pullman.

When Maj. Pullman died, August 19, 1920, Gessford was chosen superintendent. He was succeeded by Maj. Sullivan, after almost 41 years in the department.

Maj. Gessford, a native of Washington, was a member of Mount Pleasant Chapter, No. 13, R.A.M.; Mount Pleasant Lodge, No. 33, F.A.A.M., the Rotary and Kiwanis Clubs and the Board of Trade.

Funeral services will be held tomorrow at the home. Interment will be in Congressional Cemetery. A police escort will be designated by Maj. Brown, Superintendent of Police.

All flags on precinct police stations were ordered lowered to half mast.

Maj. Gessford is survived by three sons, five daughters and nine grandchildren. His wife died eight years ago.
