Mrs. Lusby Guilty

Will Serve Six Months on Grand Larceny Charge

Mrs. Santa Anna Lusby of 147 D street southeast, found guilty by Judge De Lacy in the Juvenile Court of being a female Fagan, was arraigned before Judge Mullowny in the Police Court today, on one charge of grand larceny and seven charges of petty larceny. In nearly all of the cases the testimony indicated that the defendant forced two young girls, her daughter Mary Lusby, fourteen years old and Nellie Buhler, eleven years old, to take articles while she attracted attention away from them. The woman's daughter Mary, the testimony showed, actually took most of the articles while Mrs. Lusby was near.

After hearing all the evidence Judge Mullowny found Mrs. Lusby guilty in one charge of petit larceny and not guilty in the other six cases. In announcing his decision his honor stated that in the dismissed cases he would have to convict the woman on the testimony of little Miss Nellie Buhler, and he did not care to consider uncorroborated testimony.

The sentence was six months in jail on the one petit larceny charge. In the grand larceny charge Mrs. Lusby was held for the grand jury and the bond was fixed at \$1,000. She was committed to serve the sentence of six months.
