10/24/1917 Appointed Private 1<sup>st</sup> Class, vice G.A. Schrader pensioned.

12/6/1919 Promoted to Private 2<sup>nd</sup> Class.

10/24/1920 Promoted to Private 3<sup>rd</sup> Class.

10/17/1929 Tried. Violation par. B, sec. 22, chap. 17 (Being under the influence of intoxicants) and par. M, sec. 22, chap. 17 (Conduct unbecoming an officer). Charges dismissed without prejudice to complainant.

12/16/1916 Appointed Private 1<sup>st</sup> Class, vice J.D. East resigned.

8/18/1917 Tried. Violation sec. 300 (Failing to report to station through patrol box). Guilty. Warned against a repetition.

7/13/1918 Tried. Violation par. 9, sec. 11 (Neglect of duty). Guilty. Fined \$10.00.

8/3/1918 Tried. Violation sec. 73 (Desertion). Guilty. Be removed from force.

10/4/1918 Removed after this date.

ZOLL, HARRY, Vol. 2, p. 456

2/5/1907 Appointed Private 1<sup>st</sup> Class, vice J.A. Stranley promoted.

4/8/1907 Tried. Gross neglect of duty and violation par. 235 and 236 of manual. Guilty. Fined \$20.00.

6/10/1907 Tried. Conduct unbecoming an officer and violation of par. 8, sec. 11 of manual. Charges dismissed.

9/11/1907 Charged with Neglect of duty. Guilty. Fined \$10 and warned will be cited before Trial Board if again charged with similar offense. However portion of fine may be remitted for meritorious service.

11/2/1917 Suspended without pay until date of removal, both dates inclusive.

11/23/1907 Tried. Violation sec. 61 of manual and conduct prejudicial to the Police Force. Guilty. Be removed from force.

12/13/1907 Removed.

7/1/1899 Appointed Private 1<sup>st</sup> Class.

7/15/1902 Appointed Desk Sergeant, original vacancy.

1/4/1905 Honorably discharged.

1/5/1905 Pensioned at \$10.00 per month.

1/10/1905 Pension increased to \$45 per month for one year from this date.

1/10/1906 Pensioned reduced to \$10 per month.

1/20/1906 Pension increased to \$45 per month for one year from this date.

1/20/1907 Pension increased permanently from \$10 to \$40 per month.

10/30/1911 Died.
